Exhibitor, individually or by and through exhibitor's agents, employees, guests, assigns or heirs at law does hereby expressly waive any and all rights and claims of any nature which may arise against the National Street Rod Association, Inc., the owners and lessors of the Kern County Fairgrounds or their officers, directors, employees, representatives, agents and anyone else connected with the management or presentation and further agrees to indemnify said parties from any and all claims, demands, costs or expenses arising out of exhibitor's activities while on or about the Kern County Fairgrounds.

The National Street Rod Association will endeavor to make all reasonable accommodations so that all aspects of this event are accessible to persons with disabilities.
