No motorized or non-motorized contrivances which do not comply with these requirements shall be ridden or driven on the grounds. Only recognized, single occupant handicap contrivances, motorized or non-motorized, will be allowed. The decision of the NSRA Officials will be final.

Entry fee includes vehicle entry and admission credentials for two people to all activities of the event. Participants' children sixteen and under will be furnished admission credentials free of charge. Tickets for participants' children over sixteen will be available at the regular adult admission fee. Credentials are non-transferable after registration check-in.
